

City of La Vista
Park & Recreation Advisory Committee Minutes
February 20, 2019

A meeting of the Park and Recreation Advisory Committee for the City of LaVista convened in open and public session at 7:00 p.m. on Wednesday, February 20, 2019. CALL TO ORDER

Director Scott Stopak called the meeting to order.

Stopak led the audience in the Pledge of Allegiance.

Stopak made an announcement of the location of the posted copy of the Open Meetings Act for public reference and read the Emergency Procedures Statement.

2. REPORTS FROM RECREATION DIRECTOR AND STAFF

David Karlson, Asst. Recreation Director

Senior Center

Karlson went over the Program Information for the Senior Center.

Karlson also stated that the Senior Valentine's Day Luncheon went very well, with approximately 150 registered for it. That is the most ever for that event. The Papillion High School Jazz Band Ensemble played during lunch, which was catered by Hy-Vee, and the local Papillion band "Feelin' Groovy" played after lunch.

Chairperson Lodes asked if the special events like the Valentine's are in conjunction with Papillion and Ralston? Karlson stated that for the Valentine's luncheon we pair up with Papillion, but that is the only event we do that for. Otherwise, it is just our senior center, but seniors from anywhere are welcome to come.

Denny Dinan, Youth and Adult Sports Coordinator

Dinan reported program information and added the following:

The youth basketball leagues will end this weekend, and a tournament will run from February 25 through March 3 for all twelve teams.

Dinan also stated that registrations are open for Boys Baseball, Flag Football, Youth Soccer, Soccer Clinic, Girls Softball, Coed T-Ball and Adult Softball.

South discussed the program information, including the Community Health Fair that the Employee Wellness Committee, along with help from the Recreation Department, will be hosting on Wednesday, March 27 from 10am to 2pm. South stated we had about 17 vendors so far, and will be able to take around 30. We have a number of letters sent out to area businesses.

South also mentioned the upcoming year for events such as the Splash Bash, Urban Scramble Adventure Race and the Pump, Run & 5k. Tentative dates have been set.
