SYNOPSIS

A resolution has been prepared authorizing the purchase of four (4) new loader tires for the Public Works Department from Heartland Tires & Tread, Omaha, Nebraska for approximately \$7,433.60.

They FY 2010/11 General Fund Street Operating Budget provides funding for the proposed purchase.

BACKGROUND

The purchase amount above was state as "approximately"; Heartland Tires will buy the old loader tires for \$120 each if the tire casings are still good. The tire casing cannot be examined until the existing tires are dismounted. Shop Foreman Ray Crane solicited bids for the tire purchase; only two companies responded:
