Officer Involved Shooting

WHAT WE KNOW AT THIS POINT AND CAN RELEASE:

On Wednesday, 10-3-18, La Vista officers discovered/recovered a stolen vehicle parked in the driveway of 7325 S 69th St. A Female inside the residence refused to open the door or identify herself. The vehicle was impounded by police.

This morning, Thursday, 10-4-18, and approximately 8 am, La Vista police officers responded to 7325 S 69th Street regarding a verbal disturbance involving two females in the front yard. Upon arrival two La Vista police officers made contact with two females and a male party in the front yard. The officers noticed the male party was acting nervously and was non-compliant with officer's orders to see his hands. The officers saw him reach into his waist band and reach for what they believed was a gun. Officers determined he was armed and the suspect fled into the back yard of the residence and ran northbound through back yards.

The officers put out a crime broadcast and numerous officers responded from La Vista and neighboring agencies and set up a containment perimeter. A short time later the suspect was observed running from the back of 7005 South 69th toward the street. La Vista Police Officer Nick Jeanette and the suspect became involved in a physical confrontation and the suspect broke free from Officer Jeanette and produced a handgun. Officer Jeanette then fired multiple rounds at the suspect. The suspect was not hit by any rounds and continued to flee and attempted to enter a home in the 7000 block of Emilie. He was unsuccessful and continued running westbound toward La Vista Drive.

The suspect ran to the rear of 6912 La Vista Drive and forcibly entered the back of the home. The homeowner, a 51 year old male, confronted the suspect in the kitchen of his home and became involved in a physical confrontation. During the confrontation, the suspect fired one round from a handgun. The homeowner was able to pin the suspect to the ground as LVPD officers forced entry into the home and took the suspect into custody. The weapon was still in the suspect's possession when officers made entry. The suspect was treated at the scene by Papillion Fire Department medics and transported to Midlands Hospital for treatment due to narcotic ingestion.



G Stanley Hall and the La Vista Sports Complex were notified during the incident and advised to lock down. The lockdown was lifted at approximately 0845.

The suspect is Jonathan Grund (W/M, 12-18-1992, Omaha). Grund is a convicted felon with previous gun convictions.

Grund is still at Midlands Hospital and when released he will be booked into the Sarpy County Jail for:

- Possession of a Firearm by a felon, (FELONY)
- Use of a Weapon to Commit a Felony, (FELONY)
- Terroristic Threats, (FELONY)
- Burglary, (FELONY)
- Resisting Arrest, (MISD)
- Attempted 1st Degree Assault (FELONY)

Three subjects from 7325 S 69th Street were taken into custody for active **Failure to Appear in Court** warrants.

Booked into the Sarpy County Jail were:

Officer Nick Jeanette has been placed on paid administrative leave until the use of force investigation is concluded. The Bellevue Police Department has been asked to investigate the use of force and the La Vista Police Department is conducting an internal investigation. Officer Jeanette is an 18+ year law enforcement veteran, serving the past 8 ½ years with the La Vista Police Department and before that 10 years with the Sarpy County Sheriff's Department.
