The City of La Vista Planning Commission held a meeting on Thursday, December 5, 2024, in the Harold "Andy" Anderson Council Chambers at La Vista City Hall, 8116 Park View Boulevard. Krzywicki asked if any improvements were planned in the near future for the intersection of 132<sup>nd</sup> Street and West Giles Road. Solberg explained that improvements were made to the intersection several years ago but that the next step might require an overpass to get rid of the at-grade railroad crossing, and that the cost for those improvements is so high that it is not the highest priority for the City.

Brewer inquired about staff's process for applying for grants and if there were staff dedicated for that purpose. Solberg explained that grant applications are typically completed with staff from various departments including community development, public works, and finance/administration.

Fountain communicated to the Commission that the City Council approved the Conditional Use Permit for Cimarron Terrace Phase 3.
