

City of La Vista
Park & Recreation Advisory Committee Minutes
February 17, 2021

A meeting of the Park and Recreation Advisory Committee for the City of LaVista convened in open and public session at 6:00 p.m. on Wednesday, February 17, 2021. Present was Recreation Director Scott Stopak, Asst. Recreation Director David Karlson, Youth and Adult Sports Manager Denny Dinan, Senior Services Manager Kaily Stanley, Administrative Assistant Sue Tangeman, Public Works Sports Complex Foreman Jeff Thornburg, Assistant City Administrator Rita Ramirez, Advisory Board Chairperson Pat Lodes, Members Jeff Kupfer, Brenda Mechels-Stuby and Bobette Jones.

A notice of the meeting was given in advance thereof by publication in the Papillion Times on February 10, 2021. Simultaneously given to the members of the Park and Recreation Advisory Committee and a copy of their acknowledgment of receipt of the notice are attached to the minutes. Availability of the agenda was communicated, in advance notice to the members of the Park and Recreation Advisory Committee of this meeting. All proceedings hereafter were taken while the convened meeting was open to attendance of the public. Further, all the subjects included in said proceedings were contained in the agenda for inspection within ten working days after said meeting, prior to the convened meeting of said body.

CALL TO ORDER

Director Scott Stopak called the meeting to order.

Stopak led the audience in the Pledge of Allegiance.

Stopak made an announcement of the location of the posted copy of the Open Meetings Act for public reference and read the Emergency Procedures Statement.

A. CONSENT AGENDA

1. Stopak asked for a motion to approve the minutes from the January 20, 2021 meeting. Motion made by Member Mechels-Stuby. Seconded by Chairperson Lodes. All aye. Motion carried.

2. **REPORTS FROM RECREATION DIRECTOR AND STAFF**
Rita Ramirez, Assistant City Administrator

Ramirez presented updates of on-going projects that the City is currently working on.

- Update on the 84th Street Project
 - Developer is in the final stages of financing etc. for the music venue. Hopeful that construction can begin by early summer.
 - Interface Project – This is a building that the City will construct, which will hold restrooms, concession stands, etc. for the park, and will also be leased by the music venue for their outdoor events. This project will get started once the music venue starts construction.
 - A 2nd parking garage has been designed and will ultimately be constructed where the current Chili's restaurant is located.

- West of 84th Street (currently Kelly East and West) is now part of Central Park. RDG is designing plans for a multi-use space that would be used for festivals, events, etc.
- Council asked to see plans for a pool in the area west of 84th Street as well, so RDG is drawing up plans for that also.
- City previously gathered data by asking residents what they would like to see in our parks. They did this by holding public engagement events such as a night at Heights Draft Room when it opened. The Board asked if they could see a copy of the input results. We will get them a copy.
- Ramirez also discussed Dog Parks. The City has decided to utilize land on the north side of the Library/MCC for a temporary “pop-up” dog park. This is on a trial basis, but could become permanent if used and well-liked.
- The City is just starting on a wayfinding project. One of the goals is to erect new signs in all of the City’s parks. The new signs will have the new branding and logo design also.
- Work will continue on the Thompson Creek Trail along Park View Blvd with channel and trail work on the next section of land, as was done from 72nd to Edgewood.
- Work is estimated to begin on the Applewood Creek trail that goes under Giles Road into the Portal Ridge neighborhood in early 2022.
- Lastly, Ramirez said they are still looking to construct a Memorial Plaza, that will be on the City Hall campus. Once future campus plans are determined for City Hall and the Community Center, then plans for the Memorial Plaza can be finalized and construction can begin.

Chairperson Lodes asked Ramirez if the music venue and amphitheater were one in the same? She said yes it is. It will be privately owned, and will be an indoor/outdoor venue. They will lease space in the Interface building for concessions, etc.

Lodes also wanted to state that in his opinion, the City needs to set plans and get them done, instead of consistently backing down because of one or two residents. The City needs to look at the big picture and what the majority of residents want, otherwise progression keeps getting stalled.

Member Mechels-Stuby asked what they can do to be more involved. Ramirez said that they would keep them more updated, and there would be instances where they could be on sub-committees for projects, and/or give their input on projects that are underway.

Scott Stopak, Recreation Director

Stopak gave updates on the Recreation Department:

- Bijon and Laurie Hamzie, the concessionaires for city facilities terminated their contract due to retirement. The City will be going out for contract bids to take over running the concessions at all city facilities except the pool.
- We have taken possession of the new Special Services Bus, and it is in the shop getting detail with the new City logo, name, etc. on it. It will be in service soon.
- Google has awarded a grant to the Senior Center to be used for technology upgrades.
- The Community Center is still operating under the guidelines that were set during

Covid-19 with limited hours, visitors, etc. We are consistently monitoring the current conditions to determine an expansion of hours and programming.

David Karlson, Assistant Recreation Director
