## REPORTS FROM CITY ADMINISTRATOR AND STAFF

City Administrator Gunn announced the acquisition, of property for the City Centre project, is completed. Assistant Public Works Director/City Engineer Kottmann will have a meeting Tuesday morning with the contractor and go through the overview of the demolition.

Director of Administrative Service Pokorny updated Council on the progress of the implementation of the new BS&A software.

Public Works Director Soucie announced that Jeff Calentine has been hired as the Deputy Director of Public Works. Sarpy County has announced the closing of the Sarpy County landfill soon. The 2017 spring clean-up fees will remain the same, which is the State Fee of \$1.25. Sarpy County lost tub grinder to fire so will look for alternate sources to grind Christmas trees.

## B. ORDINANCE – AMEND MASTER FEE ORDINANCE

Councilmember Sell introduced Ordinance No. 1300 entitled; AN ORDINANCE TO AMEND ORDINANCE NO.1290, AN ORDINANCE TO ESTABLISH THE AMOUNT OF CERTAIN FEES AND TAXES CHARGED BY THE CITY OF LA VISTA FOR VARIOUS SERVICES INCLUDING BUT NOT LIMITED TO BUILDING AND USE, ZONING, OCCUPATION, PUBLIC RECORDS, ALARMS, EMERGENCY SERVICES, RECREATION, LIBRARY, AND PET LICENSING; SEWER AND DRAINAGE SYSTEMS AND FACILITIES OF THE CITY FOR RESIDENTIAL USERS AND COMMERCIAL USERS (INCLUDING INDUSTRIAL USERS) OF THE CITY OF LA VISTA AND TO GRANDFATHER EXISTING STRUCTURES AND TO PROVIDE FOR TRACT PRECONNECTION PAYMENTS AND CREDITS; REGULATING THE MUNICIPAL SEWER DEPARTMENT AND RATES OF SEWER SERVICE CHARGES; TO PROVIDE FOR SEVERABILITY; AND TO PROVIDE THE EFFECTIVE DATE HEREOF.

Councilmember Hale moved that the statutory rule requiring reading on three different days be suspended. Councilmember Thomas seconded the motion to suspend the rules and roll call vote on the motion. The following Councilmembers voted aye: Frederick, Ronan, Sheehan, Thomas, Crawford, Hale and Sell. Nays: None. Abstain: None. Absent: Quick. The motion to suspend the rules was adopted and the statutory rule was declared suspended for consideration of said ordinance.

Said ordinance was then read by title and thereafter Councilmember Sheehan moved for final passage of the ordinance which motion was seconded by Councilmember Hale. The Mayor then stated the question, "Shall Ordinance No. 1300 be passed and adopted?" Upon roll call vote the following Councilmembers voted aye Frederick, Ronan, Sheehan, Thomas, Crawford, Hale and Sell. Nays: None. Abstain: None. Absent: Quick. The passage and adoption of said ordinance having been concurred on by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor, in the presence of the Council, signed and approved the ordinance and the City Clerk attested the passage/approval of the same and affixed her signature thereto.

WHEREAS, the FY17 General Fund budget includes funding for this project; and

WHEREAS Subsection (C) (9) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secures Council approval prior to authorizing any purchase over \$5,000.00.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska do hereby approve an agreement with Management Education Group, Inc. for consulting services related to management training and calibration process related to performance management system in an amount not to exceed \$21,000 plus travel expenses.

**SYNOPSIS**

A public hearing has been scheduled to consider applications for private ownership and operation of off-street parking facilities in the 84<sup>th</sup> Street Redevelopment Area. No applications have been received.

Resolutions have been prepared to initiate the process of proposed construction and acquisition of said facilities, initially fixing and establishing boundaries of the proposed district, directing notice, and establishing public hearing dates on the proposed project and creation of an off-street parking district in the 84<sup>th</sup> Street Redevelopment Area.

**FISCAL IMPACT**

Funding is provided in the FY 17 and FY 18 budgets.

**RECOMMENDATION**

Approval.

**BACKGROUND**

The Mayor and City Council have spent considerable time and effort creating a vision for redevelopment of the 84<sup>th</sup> Street corridor. This redevelopment is desirable for the City to eliminate and prevent recurrence of the substandard and blighted area, and in the process provide better retail and residential services to the City and its inhabitants, and enhance the possibility for additional tax revenues for supporting the costs of public services. The Mayor and Council in the Redevelopment Plan, as amended, and the Subdivision Agreement for City Centre, recognized the possible need for public offstreet parking. The creation of an offstreet parking district (which would include all lots, land and right-of-way within the proposed City Centre redevelopment, City swimming pool site, former golf course, and Central Park, as well as right-of-way abutting said properties), and acquisition and construction of off-street parking facilities in the district would allow the City to address the need for public offstreet parking. The engineer's estimate of the sum of money proposed to be expended pursuant to the applicable offstreet parking statutes for the proposed construction and acquisition of **initial** off-street parking facilities within said district is \$10,975,000, proposed to be paid from general taxes, special property taxes or assessments on property within the district, and/or general property taxes, with financing being provided by issuance of the City's general obligation bonds. There is a potential for additional facility construction in the future. Potential sites for such facilities are owned by the City, having been acquired at an additional approximate cost of \$1,525,482, using proceeds of a bond issue to be repaid from revenues including the additional one-half

percent local option sales and use tax approved by City of La Vista voters pursuant to Neb. Rev. Stat. Section 77-27,142.

Pursuant to §19-3311 of the Nebraska Revised Statutes, notice was issued inviting private ownership and operation of off-street parking facilities within the City. The City Clerk advises that no applications have been received, which allows the City to proceed to exercise the powers to create a district and acquire and construct off-street parking facilities. The first step of that process is providing notice and holding a hearing at the January 17, 2017 Council meeting on the creation of the proposed district. The first resolution under this item on the December 20 agenda is for that purpose. The second resolution on the agenda provides for notices and a hearing also to be held at the January 17, 2017 Council meeting on the proposed off-street parking project and to exempt any subsequent measures related to the project from any referendum or limited referendum procedures under state statute.

RESOLUTION NO.\_\_\_\_\_

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA REGARDING CITY OFFSTREET PARKING DISTRICT AND FACILITIES; MAKING FINDINGS REGARDING REQUEST FOR PRIVATE PARKING FACILITY APPLICATIONS, AND NEED FOR AND COMMENCEMENT OF PROGRAM FOR CITY PARKING FACILITIES IN THE 84<sup>th</sup> STREET REDEVELOPMENT AREA; ESTABLISHING BOUNDARIES OF PROPOSED PARKING DISTRICT; AND SPECIFYING PUBLIC HEARING DATE, NOTICE AND ESTIMATED COST OF FACILITIES.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, as follows:

1. The Mayor and Council hereby find and determine that notice inviting applications and fixing a date for a public hearing on any applications received for private ownership and operation of off-street parking facilities in the City in the 84<sup>th</sup> Street Redevelopment Area, has been published as required by Section 19-3311, R.R.S. Neb. 1997; that the public hearing was held; that no applications have been received by the City; and that the City is now authorized under the terms of such section to commence a program for the acquisition and construction of off-street parking facilities and otherwise proceed in the exercise of the powers therein granted.

2. The Mayor and Council hereby find and determine that it is necessary and advisable for the City to encourage redevelopment of the 84<sup>th</sup> Street Redevelopment Area and eliminate and prevent recurrence of the substandard and blighted area, and that for such purposes it is necessary and advisable for the Mayor and Council to proceed under Sections 19-3301 to 19-3327, R.R.S. Neb. 1997, as amended, (the "Act").

3. The Mayor and Council hereby further find and determine that it is necessary and advisable for the City to commence a program to construct and acquire off-street parking facilities within the City of La Vista, Nebraska in the 84<sup>th</sup> Street Redevelopment Area, and that for such purpose it is necessary and advisable that boundaries be established for an off-street parking district to be created pursuant to the Act and to be designated as Vehicle Offstreet Parking District No. 2 of the City of La Vista, Nebraska.

4. The boundaries of proposed Vehicle Offstreet Parking District No. 2 of the City of La Vista, Nebraska, shall be as follows:

Those outer boundaries which are the same as the outer boundaries of the Area depicted in Exhibit A, incorporated herein by this reference, and comprised of the following: Lots 1 through 17, Inclusive, La Vista City Centre, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska; together with Lot 13, Park View Heights, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska; together with Tax Lot 12 and Tax Lot 13 in Section 14, Township 14 North, Range 12 East, of the 6<sup>th</sup> P. M. in Sarpy County, Nebraska together will all right-of-ways abutting said lots. Vehicle Offstreet Parking District No. 2 of the City of La Vista, Nebraska shall include all lots, lands, streets and street right of

way located within said Area.

Said boundaries are hereby determined to include all land within the district which might be specially benefited thereby. The costs of off-street parking facilities to be acquired and constructed and the costs of operating and maintaining such facilities are expected to be paid for from general taxes, special property taxes or assessments on property within Vehicle Offstreet Parking District No. 2 of the City of La Vista, Nebraska, and/or general property taxes or other funds, with financing being provided by issuance of the City's general obligation bonds, all as provided for in the Act or other applicable statutes and from time to time determined by the Mayor and City Council.

5. 7:00 o'clock P.M. on the 17<sup>th</sup> day of January, 2017, at City Hall, 8116 Park View Blvd., La Vista, Nebraska, is hereby set as the time and place of a hearing before the Mayor and Council on the creation of said district and of protests and objections to the creation of the district. At said hearing, any protest or objections to the creation of said district as contemplated in this resolution shall be received, heard and considered. The City Clerk is hereby instructed to give notice of such hearing by publication one time each week for not less than three weeks in the *Papillion Times*, a weekly newspaper of general circulation published in the City of La Vista. Such notice to be published pursuant to this resolution shall be in the following form:



**SYNOPSIS**

A public hearing has been scheduled to consider applications for private ownership and operation of off-street parking facilities in the vicinity of 120<sup>th</sup> Street and Giles Road. No applications have been received.

Resolutions have been prepared to initiate the process of proposed construction and acquisition of said facilities, initially fixing and establishing boundaries of the proposed district, directing notice, and establishing public hearing dates on the proposed project and creation of an off-street parking district in the vicinity of 120<sup>th</sup> Street and the Giles Road.

**FISCAL IMPACT**

Funding is provided in the FY 17 and FY 18 budgets.

**RECOMMENDATION**

Approval.

**BACKGROUND**

The Mayor and City Council in the Statement of Intent approved November 3, 2015 recognized the possible need for public infrastructure improvement in and around the Giles Road and Interstate 80 interchange.

The area north of 120<sup>th</sup> Street and east of Eastport Parkway (often referred to as the sod farm) has been purchased by a private developer who intends to construct a regional recreational area to include state-of-the-art championship swimming, soccer and tennis facilities. This development is consistent with the City's comprehensive plan and will provide better recreational services to the City and its inhabitants, and enhance the possibility for additional tax revenues for supporting the costs of public services. In the interests of public health, safety, and welfare additional public offstreet parking would facilitate among other things safe and uncongested traffic flows along City streets and in and around the Giles Road and 1-80 interchange. The creation of an offstreet parking district (which would include substantially all of the sod farm area, together with Giles Road and Eastport Parkway right of ways abutting said area), and acquisition and construction of off-street parking facilities in the district would allow the City to address the need for public offstreet parking. The engineer's estimated cost of initial off-street parking facilities in the district is \$3,630,000; proposed to be paid from general taxes, special property taxes or assessments on property within the district, and/or general property taxes, with financing being provided by issuance of the City's general obligation bonds. There is a potential for additional facility construction in the future.

Pursuant to §19-3311 of the Nebraska Revised Statutes, notice was issued inviting private ownership and operation of off-street parking facilities within the City. The City Clerk advises that no applications have been received, which allows the City to proceed to exercise the powers to create a district and acquire and construct off-street parking facilities. The first step of that process is providing notice and holding a hearing at the January 17, 2017 Council meeting on the creation of the proposed district. The first resolution under this item on the December 20 agenda is for that purpose. The second resolution on the agenda provides for notices and a hearing also to be held at the January 17, 2017 Council meeting on the proposed off-street parking project and to exempt any subsequent measures related to the project from any referendum or limited referendum procedures under state statute.



**SYNOPSIS**

A resolution has been prepared to approve a Council Policy Statement regarding overhire positions.

**FISCAL IMPACT**

None. The overhire of positions would be permitted only if the costs of doing so could be covered in the existing budget appropriation and not result in a budget increase.

**RECOMMENDATION**

Approval

**BACKGROUND**

The City has experienced a number of instances, particularly in the Police Department, where it has knowledge of staffing changes such as a pending retirement, resignation or termination necessitating hiring and cross-training a replacement employee prior to the departure of the existing employee or backfilling a position for an employee on long-term disability where the employee is not expected to return for an extended period of time.

Currently, the City does not have a method to address these types of issues. In the two scenarios above, we would have to wait until the pending retirement or separation occurs to fill the position and would not be able to fill the position vacated by an employee on extended leave. This Council Policy Statement delegates to the City Administrator the authority to employ staff in excess of the positions approved by the City Council in the annual budget under these types of unusual situations.

**OVERHIRE POSITIONS**

**Issued: December 20, 2016**

**Resolution No. 16-**

**Purpose**

To delegate authority to the City Administrator to authorize hiring staff in excess of the number of positions approved by the City Council in the annual budget (overhire positions), in specified circumstances.

**Definition**

Overhire: An authorized position for which funds are not budgeted. The overhire concept assumes that a department (particularly Police) experiences several position vacancies during a fiscal year, and that the salary and fringe benefit savings from these vacancies will offset the cost of the overhire personnel. The overhire personnel, in turn, ensures that the department will not be forced to limit operations because of staffing shortages and can better control overtime expenditures.

**Policy**

The use of overhire personnel is permitted to accelerate the filling of vacant positions by initiating the hiring process in advance of actual vacancies.

**Conditions Permitting Use of Overhires**

The City Administrator may authorize employment of an overhire position in any circumstance where it is felt to be in the City's best interest.

Generally, the following circumstances would warrant consideration of an overhire request:

- a. Knowledge of a pending retirement/resignation where it is necessary to hire and cross-train a replacement employee prior to the departure of the existing employee.
- b. Knowledge of a pending vacancy where it is desirable to recruit and hire a replacement employee such that there is no reduction in staffing and service levels.
- c. Backfilling for an injured employee where the employee is not expected to return for an extended period of time, if ever.

Under all circumstances, approval of an overhire position is based upon the assumed permanent vacancy of an existing position in the near future. Positions will only be authorized following a review of the necessity for filling the position immediately as an overhire.

**OVERHIRE POSITIONS**

**Budgetary Considerations**

Approval of an overhire position is conditioned on the availability of adequate budget authority to guarantee the additional position will not exceed the authorized annual budget.

**Procedure**

Departments Heads shall submit written requests for overhire authorization to the Managing Director of the department. If approved by the Managing Director, a recommendation of approval will be forwarded in writing to the City Administrator for final approval. Notification will then be made to Human Resources and the Finance Department.

**Appointment to the Overhire Position**

The date of an employee's appointment to an overhire position is designated as the start of the employee's probationary period. An overhire is differentiated from working out-of-class in that the working out-of-class is a temporary, short-term filling of a higher-level position.

**Reporting**

The number of staff overhires will be reported to the City Council during the annual budget process.
