SYNOPSIS

A resolution has been prepared authorizing a preliminary joint Agreement with HDR, Inc. (HDR) to provide project management services for the City and La Vista Community Development Agency. The resolution would also authorize staff to negotiate a detailed scope of work and terms of an agreement to be brought back to the City Council and the Agency for consideration.

FISCAL IMPACT

The FY17/18 biennial budget provides funding for multiple potential public infrastructure improvements and associated services.

RECOMMENDATION

Approval of short term agreement in an amount not to exceed \$25,000 and authorization to negotiate a comprehensive scope of services and related agreement with HDR.

BACKGROUND

The City Council authorized a Request for Qualifications for project management services on November 15, 2016. The City Engineer solicited a Request for Qualifications. Six firms submitted their qualifications. These submittals were reviewed and three of the six firms were interviewed. After the initial interviews, two firms were brought back for additional questions and discussion.

HDR, Inc. was determined to be the company that most closely meets the City's and the Community Development Agency's needs. As such, it is recommended that staff be authorized to negotiate a scope of services and terms of an agreement with HDR to provide project management services. Due to applicable time considerations, there is a need to authorize a preliminary agreement and proceed with a limited amount of services on an hourly basis at a cost not to exceed \$25,000. While these initial services are underway, a detailed scope of work and terms of an agreement will be negotiated. The finalized agreement will be brought back to the Agency for approval. A separate agenda item will be considered for City approval in connection with such services to be provided on behalf of City. The City would directly pay for all work for the City or Agency.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA VISTA, ACTING AS THE LA VISTA COMMUNITY DEVELOPMENT AGENCY, APPROVING A JOINT PROFESSIONAL SERVICES AGREEMENT WITH HDR, INC. WHEREAS, the Community Development Agency ("Agency") consisting of and governed by the Mayor and City Council of the City of La Vista has been created; and

WHEREAS, the City Council acting as the La Vista Community Development Agency desires to approve and enter into a joint professional services agreement with HDR, Inc. to provide project management services;

NOW THEREFORE, BE IT RESOLVED that the City Council acting as the La Vista Community Development Agency hereby approves a joint professional services agreement with HDR, Inc. to provide project management services for the City and the La Vista Community Development Agency in an amount not to exceed \$25,000.00 and authorizes proper staff to negotiate a detailed scope of work and terms of an agreement.
