SYNOPSIS

A resolution has been prepared award the bid for replacement of a 100-ton chiller for the City Hall/Community Center building from MMC Contractors, Omaha Nebraska, in an amount not to exceed \$91,152.

FISCAL IMPACT

The FY17 General Fund Budget provides funding for the replacement.

RECOMMENDATION

Approval.

BACKGROUND

The current reciprocating air-cooled chiller was installed in 1993 when the building was constructed. During the cooling season last year, the unit required over \$11,000 in repairs. The repairs were a temporary fix. The evaporator head was patched together, is rusty and will leak again. A replacement is not available. The compressor for circuit 2 is likely to fail soon, operating well under half of its capacity. The new system will be a scroll type that is more efficient. Competing bids were received from 4 vendors. They were as follows:

MMC Contractors	\$ 91,152 with 5 year extended warranty.
Johnson Controls	\$104,690 with 5 year extended warranty.
Daikin Applied	\$105,576 with 4 year extended warranty.
Siemens	\$107,516 with 5 year extended warranty.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, AWARDING THE BID TO MMC CONTRACTORS, OMAHA NEBRASKA FOR REPLACEMENT OF A CHILLER FOR THE CITY HALL/COMMUNITY CENTER BUILDING IN AN AMOUNT NOT TO EXCEED \$91,152.

WHEREAS Subsection (C) (9) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secures Council approval prior to authorizing any purchase over \$5,000.00.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska award the bid to MMC Contractors, Omaha Nebraska for replacement of the chiller at the City Hall/Community Center buildings in an amount not to exceed \$91,152.
