SYNOPSIS

A resolution has been prepared authorizing the purchase of one (1) Bonnell BVDA, 12' x 4' x 12', Dual Auger Stainless Steel Spreader from Midwest Services & Sales Co., 602 Road 5, Schuyler, NE 68661 for an amount not to exceed \$15,365.00.

The FY17 General Fund Budget provides funding for the proposed purchase.

BACKGROUND

The proposed purchase is to replace the 7 year old spreader in truck #1121. The current spreader has deteriorated from salt corrosion. Currently, the stainless steel spreader in truck #1131 is 14 years old and shows no signs of corrosion. When comparing the cost of a stainless steel spreader versus a standard steel spreader can be justified by the extended life cycle of stainless steel spreaders. The new spreader will be used by all divisions for snow removal operations.

7" Hard faced auger with direct drive.

SPINNER ASSEMBLY

Swing up assembly with 18" steel spinner disc, one internal directional baffle and four external baffles - one fixed and three adjustable, which are removable without the use of tools.

TOP SCREENS

Section top screens are made of 3/8" diameter rods welded to a 1/4" x 2" angle iron frame creating a maximum opening of 2-1/2."


