**BACKGROUND**

The proposed mower purchase is to replace mower #2423, a 2008 John Deere 1445 mower. With the mower being purchased directly from Exmark Mfg. via the HGACBuy contract, J&J Small Engine is the authorized dealer and will provide warranty work, repair and parts.

The mower is being purchased off the HGACBuy contract No. GR01-15. The purchase order will be made out to Exmark Mfg. Co. Inc., the mower will be delivered to J&J Small Engine Service, 6912 S. 36<sup>th</sup>, Bellevue, NE.

Exmark Mfg. Co. Inc. in amount not to exceed \$15,598.00.

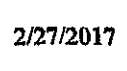
