**SYNOPSIS**

A resolution has been prepared authorizing the purchase one (1) VeriSight Pro+ Push Camera from Nebraska Environmental Products for an amount not to exceed \$10,116.00.

**BACKGROUND**

Currently the sewer division utilizes the large camera truck to televise and diagnose problems with sanitary and storm sewer lines. Due to the size of this camera system it cannot get into lines that are 6" in diameter or less. The proposed push camera purchase would allow the sewer division to diagnose issues in these smaller lines, while providing a better mobile application compared to the camera truck.
