**SYNOPSIS**

A resolution has been prepared authorizing the execution of Interlocal Agreement Addendum #2 Geographic Information System.

**FISCAL IMPACT**

La Vista's participation for FY18 - \$8,078 and FY19 - \$8,977. Funding for the GIS Coalition is included in the General Fund Operating Budget.

**BACKGROUND**

On March 5, 2002, the City Council passed Resolution No. 02-022 authorizing the Mayor to execute an Interlocal Cooperation Agreement with Sarpy County, the cities of Gretna, Papillion, Springfield, Bellevue and the Papio Missouri River Natural Resource District for the development and implementation of a Geographic Information System (GIS). On October 2, 2007, the City Council passed Resolution No. 07-106 updating the GIS Interlocal Agreement and creating a coalition GIS user group.

Addendum #2 of the GIS Interlocal Agreement includes updated cost shares for the 2018 Aerial Photo Share and total cost share for the Fiscal Year 2019 outlined in Exhibit A. The 2018 Ortho Photograph cost shares will be added and incorporated as part of this agreement as outlined in Exhibit C.

The GIS system continues to be a valuable asset and working tool as it is used extensively by most departments in the city.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, APPROVING THE EXECUTION OF ADDENDUM #2 TO THE INTERLOCAL COOPERATION AGREEMENT FOR GEOGRAPHIC INFORMATION SYSTEM (GIS) WITH SARPY COUNTY, AND THE CITIES OF GRETNNA, PAPILLION, BELLEVUE, AND SPRINGFIELD.

WHEREAS, each Party to the GIS Interlocal Cooperation Agreement is authorized pursuant to the Interlocal Cooperation Act of the State of Nebraska to enter into such Agreement, found at 13-801 et. Seq. Neb. Rev. Stat., '43, Reissue 1991; and

WHEREAS, each Party engages in the delivery of sundry services to the public supported by information regarding real estate, sewers, water, infrastructure, etc; and

WHEREAS, each Party desires to improve the coordination, cooperation, and efficiency in rendering such services through the development and implementation of a Geographic Information System (GIS); and

WHEREAS, the Parties had previously entered into an agreement for the first and second phase ("Phase I" and "Phase II") of achieving the GIS being the creation of a base map; obtaining related equipment necessary to utilize it; training for users; technical support; obtaining digital aerial photography and contours and creating and maintaining GIS data and projects for municipalities and creation of a coalition GIS user group; and

WHEREAS, the Parties desire to share costs for the 2018 Aerial Photo Share and total cost share for the Fiscal Year 2019; and

WHEREAS, each Party understands that the development, operation and maintenance of the GIS will require long term commitment from the Parties; and

WHEREAS, additional phases and enhancement to the GIS will be determined by the financial considerations of all Parties to the Agreement primarily based upon the recommendations of the GIS User Group.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the La Vista, Nebraska, hereby approves the addendum #2 to the Interlocal Cooperation Agreement for Geographic Information System (GIS) with Sarpy County, and the cities of Gretna Papillion, Bellevue and Springfield; and authorizes the Mayor to execute said agreement.

**ADDENDUM #2 TO GEOGRAPHIC INFORMATION SYSTEM (“GIS”)  
INTERLOCAL AGREEMENT**

This Addendum is entered into by and between City of Gretna, Nebraska (“Gretna”), City of Papillion, Nebraska (“Papillion”), City of Bellevue, Nebraska (“Bellevue”), City of La Vista, Nebraska (“La Vista”), City of Springfield, Nebraska (“Springfield”), (hereinafter collectively called “Cities” or a “City” when used in the singular), County of Sarpy, Nebraska, a body politic and corporate (“Sarpy”), and the Papio Missouri River Natural Resource District (“PMRNDRD”), (collectively the “Parties” or “Party” when identifying each individually).

WHEREAS, the Parties have previously entered into an Interlocal Agreement and First Addendum to said Agreement in order to develop and implement a Geographic Information System (“GIS”); and,

WHEREAS, the Parties are desirous of amending the provisions of said Agreement and First Addendum by this Second Addendum.

NOW, THEREFORE, it is hereby agreed by and between the parties:

I.

The prior Agreement and Addendum between the parties is hereby amended by the terms of this Addendum.

II.

Exhibit A shall be amended to include updated Cost Shares for the 2018 Aerial Photo Share and the Total Cost Share for Fiscal Year 2019 shall be updated accordingly.

III.

Exhibit C outlining the 2018 Ortho Photography Cost Shares shall be added to and incorporated as part of the Agreement.

IV.

Each Party shall make payment and otherwise perform under the terms of the previous Agreement and the subsequent addendums thereto, applying the amendments of Exhibit A and C attached hereto.

V.

The remaining terms and conditions of said prior Agreement and Addendum shall remain unchanged.
