SYNOPSIS

A resolution has been prepared to award a contract to Burton Plumbing in an amount not to exceed \$12,709.78.

FISCAL IMPACT

The FY19/20 Biennial Budget includes funding for the proposed maintenance.

BACKGROUND

During the course of routine inspections, the Sewer Division found a 12 foot long section of public sanitary sewer in the northwest corner of the former golf course clubhouse parking lot that is badly deteriorated. Removal and replacement is required.

Proposals were solicited from three contractors that perform this type of work in the Omaha area. Only one bid was received from Burton Plumbing in the amount of \$12,709.78. The Sewer Division will be providing assistance to the contractor by pumping sewage in an upstream manhole to allow the repair to be made.

RESOLUTION NO.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, AWARDING A CONTRACT TO BURTON PLUMBING, OMAHA NEBRASKA FOR SANITARY SEWER REPAIRS IN AN AMOUNT NOT TO EXCEED \$12,709.78.

WHEREAS, the City Council of the City of La Vista has determined that the removal and replacement of a section of public sanitary sewer at 8503 Park View Blvd. is necessary; and

WHEREAS, the FY19/FY20 Biennial Budget provides funding for the proposed maintenance; and

WHEREAS, bids were solicited, and one bid were received; and

WHEREAS Subsection (C) (9) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secures Council approval prior to authorizing any purchase over \$5,000.00;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska award the contract to Burton Plumbing, Omaha Nebraska for Sanitary Sewer Repairs in an amount not to exceed \$12,709.78.

Burton Plumbing will dig and replace a section 12' long to include the following:

1. Backhoe and operator
2. Laborers
3. Haul off asphalt
4. Rock for bedding and top layer
5. Shoring boxes
6. Backfill and compact
7. Dump truck and driver
8. Pump truck for the hole that we dig

Sum of Labor and Materials \$12,709.78

Note 1: City of LaVista will suck out manhole for bypass while we hook up section of pipe.

Note 2: Any unforeseen problems will be addressed with John.

All material is guaranteed to be as specified. All work to be completed in a professional manner according to code requirements and standard practices. Any alterations or deviations from the above specifications involving extra costs will be executed only upon written orders, and will become an extra charge over and above the estimate. All agreements are contingent upon strikes, accidents, or delays that are beyond our control. Owner is to carry fire, tornado and other necessary insurance. Our workers are fully covered by Workers Compensation Insurance. Under normal conditions, we have a 2-year parts and labor warranty. **NOTE:** This proposal may be withdrawn if not accepted within 30 days.
