SYNOPSIS

A resolution has been prepared to approve the purchase of equipment needed to implement the security camera and Parking Access and Revenue Control (PARCS) systems in Parking Structure I located at 8121 City Centre Drive, in an amount not to exceed \$13,000.

BACKGROUND

In the interest of safety and security, the construction of Parking Structure I includes the installation of security camera and Parking Access and Revenue Control (PARCS) systems. The above equipment will allow for these systems to be networked into the City's existing infrastructure and for remote viewing and configuration of the security cameras.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA AUTHORIZING THE PURCHASE OF THREE (3) SECURITY CAMERA VIEWING STATIONS WITH MONITORS FROM DELL ONLINE STORE, ONE (1) EXTREME X440-G2 48-PORT NETWORK SWITCH FROM C1 HOLDINGS CORP., ONE (1) DELL POWER EDGE SR6415 SERVER, AND PLUGGABLE TRANSCEIVERS AND FIBER CABLING FROM AMAZON.COM IN AN AMOUNT NOT TO EXCEED \$13,000.

WHEREAS, the City Council of the City of La Vista has determined that the purchase of security camera and Parking Access and Revenue Control (PARCS) systems for Parking Structure I are necessary; and

WHEREAS, the FY19/20 Biennial Budget provides funding for the proposed purchases; and

WHEREAS, Subsection (c) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secure Council approval prior to authorizing any purchase over \$5,000.00;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska, do hereby authorize the purchase of three (3) security camera viewing stations with monitors from Dell Online Store, one (1) Extreme X440-G2 48-port network switch from C1 Holdings Corp., one (1) Dell Power Edge SR6415 server, and pluggable transceivers and fiber cabling from Amazon.com in an amount not to exceed \$13,000.
