**SYNOPSIS**

A resolution has been prepared authorizing the purchase of a Scotsman Ice Maker machine from Buller Fixture Company, Omaha, NE in an amount not to exceed \$13,823.17.

**FISCAL IMPACT**

The FY23/FY24 Biennial Budget includes funding for the proposed purchase.

**BACKGROUND**

An ice maker machine was originally included in the kitchen equipment proposed for the Link. During the design process this piece of equipment was removed as there was discussion regarding whether the beverage vendor would potentially provide it. The vendor does provide ice bins for storage, however they do not provide the actual ice maker machine. Consequently, the City needs to now purchase this equipment.


