**SYNOPSIS**

A resolution has been prepared authorizing the Mayor and City Clerk to sign a Task Order Agreement on behalf of the City of La Vista with Alfred Benesch & Company to provide construction engineering services for the 96<sup>th</sup> Street, Portal-Harrison Pavement Rehabilitation project, a federal-aid project designated as Project No. MAPA-5017(4).

**FISCAL IMPACT**

The FY 2011/12 Capital Improvement Program provides funding for the 96<sup>th</sup> Street, Portal-Harrison Project.

**BACKGROUND**

In order to comply with the regulations pertaining to the oversight of federal-aid projects a Construction Engineering Consultant is necessary to conduct the required observations, testing and recording keeping associated with the construction of the project. Alfred Benesch & Company was selected from a list of On-Call consultants for such services and a fee for the services was negotiated using the processes set forth by the Nebraska Department of Roads. The estimated cost of the construction engineering services is \$65,340.83. The construction and construction engineering for the project are eligible for 80% Federal aid.

WHEREAS, the City of La Vista and Alfred Benesch & Company wish to enter into a Professional Services Agreement to provide construction engineering services for the Federal-aid project; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of La Vista, Nebraska that Douglas Kindig, Mayor of the City of La Vista, is hereby authorized to sign the construction engineering services agreement between the City of La Vista, Nebraska and Alfred Benesch & Company.
