SYNOPSIS

A resolution has been prepared to establish a "No Parking Zone" on the south side of Park View Boulevard from the centerline of 73rd Avenue to the west for 90 feet.

FISCAL IMPACT

The FY15 General Fund Budget contains funds for proposed signage.

RECOMMENDATION

Approval

BACKGROUND

This proposed resolution is being recommended to prevent parking adjacent to the street planter that was recently constructed so that passengers in a vehicle do not step into the basin which is recessed below the street in order to receive and treat runoff.

The installation of a street planter was done as a demonstration project for storm water management and is part of an effort to improve water quality in the Thompson Creek Watershed. This is also a requirement as part of the grants received for the Thompson Creek Watershed Restoration project. The street planter must be constructed below the gutter line elevation of the street so that storm water can run into the planter for infiltration and filtering.

Attached is a map illustrating the existing No Parking Zone.

BE IF FURTHER RESOLVED, that the Public Works Department be, and hereby is, authorized to install the appropriate signage designating this a "No Parking Zone".

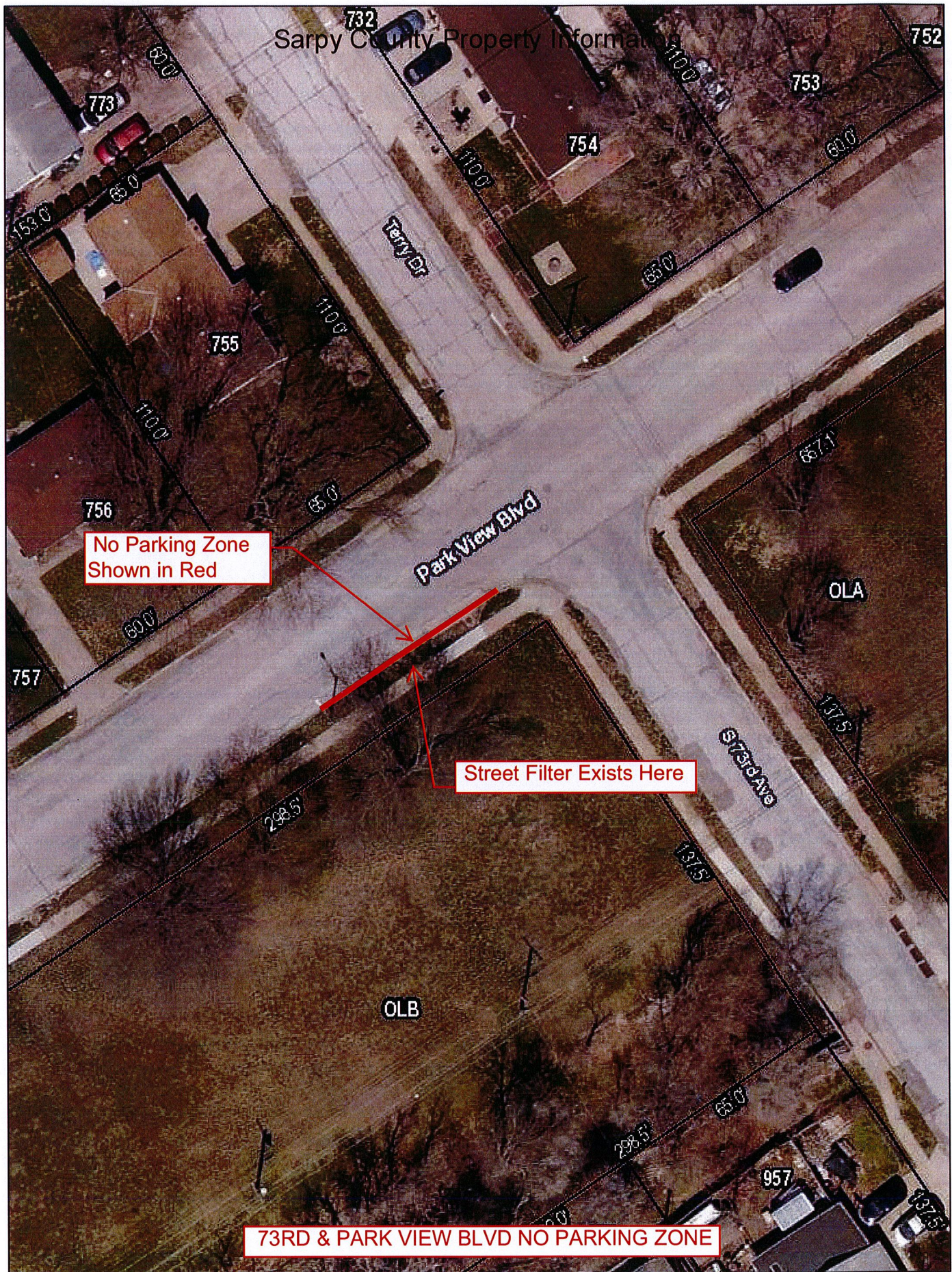
