SYNOPSIS

A resolution has been prepared authorizing the advertisement of bids for construction of the Thompson Creek Landscaping for an amount not to exceed \$30,000.

FISCAL IMPACT

Funding of \$30,000 has been included in the FY17 Budget, currently in the adoption process, for Thompson Creek Landscaping. The award of the contract will not occur until the FY17 budget is finally approved.

BACKGROUND

RDG Planning & Design prepared the landscaping plans that include furnishing and installing shrubs and trees on approximately 40 properties at the edge of the channel easement along the rear of these lots abutting Thompson Creek. The expectation is for the planting to be done this fall. Planting will not occur on a property if the owner declines the opportunity. The owners will be responsible for maintenance and the City will not guarantee the plantings beyond the nursery's normal warranty.

Sealed proposals will be received by Pamela Buethe, City Clerk of the City of La Vista, at City Hall, 8116 Park View Boulevard, La Vista, Nebraska 68128, until September 9, 2016, at 10:00 A.M., for Thompson Creek Landscaping, in and for said City according to the Plans and Specifications now on file at the office of the City Clerk.

The extent of the work includes furnishing and installing overstory trees, understory trees, ornamental trees and shrubs on the rear of residential lots abutting the Thompson Creek Channel.

In order to ensure bidders are aware of all issued documents pertaining to this opportunity – bids will only be accepted from those listed on the planholders list kept at the offices of Standard Digital Imaging / StandardSHARE.

All proposals must be submitted on the Proposal form prepared by the La Vista Public Works Department. This form is part of the documents that can be obtained at the StandardSHARE web site or offices.

Each bid shall be accompanied in a SEPARATE SEALED ENVELOPE by a certified check or bid bond in an amount not less than five (5) percent of the amount bid and such certified check or bid bond shall be payable to the Treasurer of the City of La Vista, Nebraska, as security that the Bidder to whom the contract may be awarded will enter into a contract to perform the work in accordance with this Notice and other contract documents, and will furnish the required bonds in amount equal to 100% of the contract price.
