**SYNOPSIS**

A resolution has been prepared authorizing the Public Works Department to purchase (1) Lumberjack Series 100 – Sewer Cleaning Attachment from Municipal Pipe Tool Company, Inc., Hudson, Iowa, for an amount not to exceed \$7,980.00.

The FY 2006/07 Sewer Maintenance budget provides funding for the proposed purchase.

**BACKGROUND**

The Lumberjack is a high-speed sanitary sewer line cleaner. The unit attaches to the end of a sewer jet hose and is placed in the sanitary line. Chains on the end of the unit rotate at a high speed cleaning virtually everything that could be encountered in a sanitary line, including grease, grit, roots, scaling and lateral line intrusions.

Municipal Pipe Tool Company is the sole provider of this product in the Midwest.
